Wilton is given the floor. He expresses frustration about accessibility; it's hard to locate meeting minutes, images on Facebook do not cut it. Curious why there aren't facebook events for all meetings. Wants to know if his complaints and frustrations are being recorded in the minutes. Gilbert states that the Admin Asst hire should help with our processes. Blair adds that efforts have been made by the BHRC to have BHRC website page updated to include all minutes and correct contact info and to add meeting video to the City vimeo channel but the City has not responded.

  raised important concerns and we question whether these things reflect Berea in a positive light.
- Communicate with Wilkins about his complaint. Does not appear to meet our narrowly defined charge. Fontanez will draft response letter.

BHRC will draft a letter of concern to the BCOC. Send to The Berea Citizen as well. Pride will draft??

It is the recommendation of the screening committee is to make official recommendation to the Mayor to hire Michael Harrington. Unanimous vote to accept recommendation. Shroyer's email forwarded to the Mayor by Gilbert.
