STONEY CREEK, UNIT 3, PHASES 1A & 1B AND WYLDWOOD WAY STREET ACCEPTANCE

Amanda Haney, Administrator, Codes and Planning Office, requested acceptance by City Council of Stoney Creek, Unit 3, Phases 1A & 1B and Wyldwood Way. Codes & Planning and Public Works inspected Stoney Creek Unit 3, Phases 1A & 1B and Wyldwood Way. All infrastructure was complete, and deficiencies had been corrected. The streets in Phase 1C will be accepted at a future date; construction of homes was still underway.

The street right of way for acceptance into the city maintenance consisted of:

Wyldwood Way – approximately 415 If of boulevard entrance from Richmond Road (90' ROW width) Wyldwood Way – approximately 1200 If from the boulevard entrance to the roundabout (60' ROW width)

Wyldwood Way – approximately 650 If at the intersection of Stillwater Drive and Brook Cove (60' ROW width)

Stillwater Drive – approximately 1710 If (50' ROW width)

Stoney Creek Way – approximately 465 lf (60' ROW width)

Middle Creek Way – approximately 330 lf (50' ROW width)

Brook Cove – approximately 515 If (50' ROW width)

Detention ponds, P-5 and P-6, shown on the preliminary plat had a recorded stormwater maintenance agreement to be maintained by the owner / developer, Stoney Creek Holdings.

Total asset to the city was 5285 linear feet of street right of way including sidewalks, curb, and gutter in the amount of \$2,292,000. This value included the ROW width for the boulevard entrance at Wyldwood Way.

Berea Municipal Utilities had inspected and approved the following:

Wyldwood Way: Approximately 795 LF of 8" PVC gravity sewer pipe and 4 newly installed manholes. (Capital Addition Value: \$81,955.00)

Stoney Creek Unit 3, Phase 1B: Approximately 3,650 LF of 8" gravity sewer pipe and 15 newly installed manholes. (Capital Addition Value: \$ 350,800.00)

Stoney Creek Unit 3, Phase 1C: Approximately 3,600 LF of 8" gravity sewer pipe and 15 newly installed manholes. (Capital Addition Value: \$347,500.00)

Total asset value to the city is \$780,255.00

Caudill motioned; Little seconded motion to accept 5285 linear feet of street right of way including sidewalks, curb, and gutter at Wyldwood Way, Stillwater Drive, Stoney Creek Way, Middle Creek Way, and Brook Cove. The total asset to the city being \$2,292,000.00; and approximately 8,045 LF of 8" PVC gravity sewer pipe and 34 newly installed manholes for a total asset to the city in the amount of \$780,255.00. Detention ponds were to be maintained by the Stoney Creek Holdings in accordance with the recorded stormwater maintenance agreement.
