DEPARTMENT HEAD REPORTS

Nancy Conley, Director, Tourism

- Reminded everyone of the Berea Craft Festival, scheduled for July 11th July 13th.
- To show the value of Tourism for Kentucky and Berea, shared the following 2024 Economic Impact Statistics of Tourism in Kentucky, of travelers and/or visitors traveling more than fifty miles to their destination of Kentucky, the Bluegrass Region, or Madison County:
 - 80M travelers visited Kentucky in 2024, spending a total of \$10.1B across the state in which \$1B of this spending was contributed to state and local taxes.
 - Madison County's 2024 Tourism Economic Impact was at \$243.7M.

Felt having a diversified economy and marketing approach was ideal for Berea. Intentions were to strengthen and diversify their marketing approach, being strategic about marketing and gain from all sectors of Tourism.

In 2024, Berea Tourism welcomed and served 16,707 visitors.

Amanda Haney, Administrator, Codes & Planning Department

A public survey would soon be sent out regarding the Berea Beyond 2025 Comprehensive Plan Project which would assist the consultants in gathering as much public information as possible.

Questions of interest would include local property owners, those who received their education in Berea, those who worked in Berea, and those who liked to visit Berea. The survey would assist in focus for the Comprehensive Plan for Berea, i.e., attention items, challenges, businesses, transportation improvement, changes vs. non-changes. The public would also be notified of additional upcoming opportunities for public input.

CITY ADMINISTRATOR'S REPORT

- On behalf of all employees, thanked Council for passing the FY26 Budget.
- Reverse Salt Auction, held by the Kentucky League of Cities (KLC) had been completed. Bid had been accepted for Morton Salt at cost of \$112/ton, delivered to the City of Berea.
- Fire Chief, Russell, and Police Chief, Hays, had been working with Madison County School's Ignite South on a Career Pathway for firefighters and police officers.
- Bluegrass Recreation planned to begin installation of the shade structure in the Park System on June 23rd; weather pending.
- Berea Pool was approximately 50% complete.

MAYOR'S REPORT / COMMENTS

- Complimented Sandlin on the hard work and dedication on the FY26 Budget, nice job. Thanked all involved with the budget process.
- Construction had begun on installation of the Safe Haven Baby Box at Fire Station #2 on Glades Road.
- Bloom, Parks & Rec Director, was preparing for July 4th event/activities, scheduled for Friday, July 4th, 6:00 p.m. – 10:00 p.m., City Park located behind Berea Community School.
- The Smithsonian magazine had named Berea as one of the fifteen best small towns to visit in 2025. This spoke well of our entire City, especially Tourism and efforts in making Berea attractive.

Little Agreed with Startzman's comments regarding in-person Department Head Reports.

Thanked Sandlin, Helton, and all Department Heads for putting together a thoughtful, complete budget as it reflects our values as a City Government. Encouraged everyone to view the online budget document. Tourism's information was fantastic and showed Tourism was a huge part of the industry for Kentucky. Although he did not like the fact of an electric rate increase, the positive was that there had not been an increase since 2013. No increase was due to important leadership decisions during that time period.

Wilson Helton, great budget. Conley, informative and great, glad to have her back. Haney, cannot wait for the Comprehensive Plan survey. Appreciated all City employees, they make our City. Thanked Little for the insight, five years ago, regarding electric savings.

Startzman Requested an update on Capital Projects, possibly in July. Although notified of a shift to a written Department Head Report, preferred in-person reports and had concerns of informing the public and lack of relationship.
